Membership Classes & definitions

All **boat owners** are required to be ordinary/intermediate members.

Points and or prizes for the purposes of club racing may only be awarded to ordinary, intermediate or junior members who are fully paid members of SAS.

1. Ordinary Member -

- 1.1. Any person over the age of 28 who has satisfied the Membership committee that he or she is interested in the objectives of the Club and wishes to become a member shall be eligible for membership to the Club.
- 1.2. The Spouse or recognised partner of any Ordinary Member is automatically recognised as an Ordinary Member for the period that the spouse or partner remains a fully paid up member.

2. Dependant Member -

- 2.1. Shall be dependants of paid up Ordinary Members, under the age of 18 as at 31 December
- 2.2. Persons undertaking full time tertiary education are considered not to be financially self-sufficient.
- 2.3. The Club shall not provide for members under the age of 16 years unless they are under the supervision of an adult member.

3. Social Member -

- 3.1. Shall be such persons who apply for such status, or are granted a social membership by decision of the Committee in accordance with clause 6.1.5 herein, provided that their application is supported by a minimum of two (2) signatories from existing members of the Club and is approved by the Management Committee, and provided that such applicants are not active in any water sport activities on the Witbank Dam and do not own any water borne craft.

- 3.2. Such Members are not entitled to vote.
- 3.3. Social membership will apply for a period of one (1) year thereafter the Social member must reapply for membership to the Club.
- 3.4. Such members will not be entitled to use the camping facilities of the Club save and unless they are a guest of an Ordinary member.

4. Bankenveld Member -

- 4.1. A natural person (i.e. Legal Person) and his immediate family owning property in Bankenveld estate. Membership is not transferable. Membership must be applied for in the normal manner, which application shall be approved or declined at the sole discretion of the club.
- 4.2. All Bankenveld Members who have become members of the club shall at all times be subject to the rules and regulations of the club.
- 4.3. A Bankenveld property owner may qualify as an ordinary member, by application and payment of the required annual subscription.

5. Junior Member -

- 5.1. Shall be Members, between the ages of 16 and 21
- 5.2. Are a student at a University, Technicon or other institution (Must have a valid student card)
- 5.3. The Club shall not provide for members under the age of 16 years unless they are under the supervision of an adult member.

6. Intermediate Member -

- 6.1. Shall be young Members, between the ages of 21 and 28
- 6.2. The Spouse or recognised partner and dependants of any intermediate member are automatically recognised as an Intermediate Member for the period that the spouse or partner remains a fully paid up member.

7. Pensioner Member –

- 7.1. Shall be members over the age of 65 as at 1 July
- 7.2. Shall be considered an ordinary member

8. Racing member

- 8.1. Shall be a member in good standing of another Yacht Club who wishes to store their boat at WYAC
- 8.2. Shall be considered an ordinary member without voting rights

9. Event Membership

- 9.1. Any person who is currently not a member of a Yacht club and who wishes to participate in a SAS sanctioned National or Provincial regatta.
- 9.2. All persons who wish to participate will be required to join at a fee of 10% of the present ordinary membership fee as amended from time to time.
- 9.3. All persons shall also be required to be a SAS member and provide proof of such membership at the entry of the event.
- 9.4. EVENT membership shall be valid for a period of one (1) month from date of payment.
